- 6. The tanker truck had a fire underneath. All American Fire will do the repairs, and an insurance claim was submitted. The claim payment from OTARMA will be \$4,142.69 after the \$1000 deductible. The towing bills were submitted, as well as a fee from Buckeye Apparatus.
- 7. The Board discussed the Assistance to Fire Fighters grant that was awarded to purchase new extrication rescue tools. (AMKUS) The total cost is \$82,250 of which 5% of that is the Township's share. An additional \$29,100 was spent on additional items outside the grant. The old tools were traded in for \$10,000.

Fiscal Officer Business - Snyder

8. **Snyder** shared that it was very likely the Township would need an advance on the 1st half property taxes, and requested that the Board approve the advance request, and for Snyder to prepare the necessary letter for Auditor Jeff Lehner. She felt that the advance could be received the 3rd week of February, well ahead of the usual time in March when the receipts were paid to the townships.

- 12. **Cottrill** discussed the OTA Winter Conference from 2/7 2/9. He plans for himself and Nick Haines to attend. There is a pre-registration fee. Snyder shared that the Twp would cover the cost of the hotel and meals.

- 13. **Floral Hills**. Cottrill provided a brief update. He stated that Huntington Twp will get this cemetery. More activity is scheduled at the Court at the end of January.
- 14. **Pick up truck** being sold by the school. Hopkins discussed this truck, and the Board's desire to obtain the truck for the Road Crew. The school had tried to sell it for \$5,000 but no one was interested. It does have a plow attached. There is a Board meeting tonight where it will be discussed, but the Twp would like to get it for free.
- 15. **Cottrill** discussed the annual OTARMA annual grants. The Twp grant will be used for a weed-eater and tiller for the cemetery. The FD will use their's for flashlights and back up cameras.
- 16. Brief mention was made of the **SAFER Grant**, and the need to identify candidates for the 3 full-time positions.
