1. Keiser Road: 1 mile @ 17 ft wide (10,266 sq. yards) – 405 CCAP cold mix paving. 1 1/2” thick. Tack this road only. Apply #9 Limestone for choke down.
2. Baptist Hill Road: 2 miles @ 17 ft wide (20,553 sq. yards) – 405 CCAP cold mix paving. 1 1/2” thick. Apply #9 Limestone for choke down.
3. Rinehart Road: .7 miles @ 15 ft wide (6,776 sq. yards) – double chip & seal with #9 limestone. Use .50 to .60 oil per sq. yard on chip and seal. Seal CCAP with .45 sq. yards when paving is cured.
