APRIL 27, 2022

President Gary Hopkins called the April 27, 2022 special meeting to order at 6:00 P.M. at the Township Firehouse.

The Board met to discuss the request of Twin Township to sign a mutual aid agreement with them which would last one year, and for which Huntington Township would bill Twin \$350 for each transport and \$250 for each non-transport for which we respond to in their township. There was discussion regarding hard vs soft billing as well as if we limit the geographic area within which we would respond. For example, a 15 mile radius. Or east of St Rt 50. A suggestion was made that a map be drawn that showed the area where we would respond, but ultimately Trustee John Cottrill suggested that we keep it simple, and sign the agreement as written except to change the hospitals to which we would transport. It was noted that the agreement could be modified with a 30-day notice by either party to the agreement. In addition, FO Snyder shared that their FO Bill Jones said that Twin was asking Scioto, Union, and Paxton to sign similar agreements.

**Motion** by John Cottrill, seconded by Larry Kellough to sign and enter into the mutual aid agreement with Twin Township as presented. (Copy attached.)

Snyder distributed ORC code regarding the bid process for townships.
