## HUNTINGTON TOWNSHIP SPECIAL MEETING AUGUST 21, 2023

President Gary Hopkins called the August 21, 2023 meeting to order at 7:30 A.M. at the Township Garage.

#### **Revisit 2023 Chip ad Seal work on Twp roads:**

Trustee Cottrill spoke to the Board about changes he wished to make in the chip and seal work that had been bid out and a winner selected. A summary of the changes:

- 1) An error in measuring Pendleton Road it is .4 miles, not .2 miles.
- 2) Hartwood only needs to be a single coat, not double, except for the hill. The cost of additional mileage on Pendleton will be offset by the change from double coat to single coat on Hartwood
- 3) He said that Willet is in really bad shape and it would take \$32,000 to double coat it in chip and seal for .65 miles.
- 4) Cottrill then said that he and Wilt decided that ¼ mile of each Shaeffer and Hartwood needed to be double chipped. It will cost \$17,000 more to double chip those sections
- 5) The total increase is \$49,000, which when added to the total bid award of \$220,660 brings the grand total to \$269,660.

FO Snyder said was the most she had seen the Twp spend in one year on chip/seal, and wondered if Willet could be delayed, or the ARPA funds could be used to pay the excess that is not available with ARPA funds.

Trustee Kellough stated that single coat of chip/seal is a waste of money. He stated that it does not last and we would be better off paving roads over time.

Wilt asked if we had let resident Jason Gibson know that we would be doing work on his road so he could keep his big trucks off it. Cottrill said he had spoken to him.

Cottrill asked several times "Okay guys what are we going to do?" Ultimately he made the motion as follows.

**Motion** by John Cottrill, second by Gary Hopkins to make the above noted adjustment to the 2023 chip and seal program, using ARPA funds to pay for the approximate excess above our regular funds; around \$81,740.
