

# Invitation to Bid

## 1987 FORD F350 4 X 4 Huntington Township Fire Department Chillicothe, Ohio



The Huntington Township Board of Trustees of Chillicothe, Ohio is accepting sealed bids to sell a 1987 Ford F350 (1 ton) 4 X 4 truck (used by the fire department as a grass/brush truck). The truck had 29,470 miles on it at the time of this posting but has potential to go up. Bids must be submitted in person, or by mail/delivery to the Huntington Township Trustees, Robin Snyder, Fiscal Officer 1111 Windy Ridge Road, Chillicothe, Ohio 45601. No bids will be accepted via email, or word of mouth, NO EXCEPTIONS. Bids must be submitted on the attached form and be submitted sealed in an envelope. All envelopes shall be clearly marked "1987 FORD F350".
